At the regular meeting of the Canton Union School District #66 Board of Education on October 17, 2016 the following items took place:

- 1. The regular meeting of the Canton Union School District #66 Board of Education was called to order at 7:00 PM by Board Vice-President Jane Lewis in the boardroom at the Administration Building.
- 2. Board members present were Lori Coleman, Justin Jochums, Matt Kees, Jane Lewis, Jake Snowman, and Tom Snowman. Board member Leonard Barnard joined the meeting in progress.
- 3. Amendments to the Agenda- Remove from the Agenda: 10-D.1, William McCullum, Volunteer Assistant Varsity Boys Basketball Coach, Canton High School (required paperwork not submitted).
- 4. - 7. Auditor Tim Custis from Gorenz and Associates, Ltd. presented a report on the Canton School District's FY16 audit. The district was designated *Financial Recognition* status by the state. The Board took action to approve the audit as presented.
- 8. Action was taken to approve the proposed goals for the district and for the superintendent as presented.
- 9. The Board approved a three-year lease \$8,808.40 per year) with Midwest Bus Sales, Inc. for one activity bus (2016 14-Passenger Thomas My Bus Minotour MFSAB).
- 10. Finance Director Robin Tonkin presented the tentative 2016 Tax Levy. The tax rate is anticipated to be approximately \$3.90 per \$100 of EAV, if no new bonds are issued in 2016. The Board will take action in November 2016 to approve the Tax Levy.
- 11. District Architect Bill Phillips presented a three-year summary of roofing projects for proposed Life Safety Amendments and explained the process and timeline for the issuance of life safety amendments and approval from the state. The architect will review the estimates provided and do a comparison to recent actual bids. By consensus of all board members present, the architect was directed to prepare the necessary documents and proceed with the Life Safety Amendments, with anticipated action at the November regular board meeting.
- 12. Quotes from Lincoln Office and CDW-G for equipment, installation, and room preparation for implementation of STEM at Ingersoll Middle School were provided to board members. In early November 2016, teams from District #66 will visit elementary, middle, and high schools with STEM Programs in place. Team members will provide reports to the Board in November prior to discussion on a timeline for bids. Local institutions have indicated interest in donating to the project and \$5000 from a *Race To the Top* Grant will cover some professional development and curricular aspects.
- 13. Questions on the IASB Resolutions Committee Report to the Membership should be directed to the District 66 delegate, Justin Jochums.
- 14. Board members were provided with the timeline for the April 4, 2017 school board election.

- 15. Once the conference mailing from IASB is received at the district office, CUSD #66 board members will be provided a complete packet of Joint Annual Conference materials.
- 16. Cross country state qualifiers will be recognized by the Board at the December regular board meeting.
- 17. The Board entered closed session to discuss personnel matters, negotiations, and student discipline matters.
- 18. The regular board meeting adjourned at 9:26 PM.
